PAYMENT TERMS: Charlotte Chocolate Fountains is holding a tentative reservation for the Clients event until 14 days after the above Contract. To confirm this agreement, return signed and completed copy of this contract along with a deposit of \$200.00 within 14 days. Agreements received after 14 days from the contract date are subject to availability. The balance is due no later than 14 days prior to the date of the event and can be paid in cash, check or money order. All checks should be made payable to Charlotte Chocolate Fountains. There will be a \$30.00 fee charged for all returned checks.

OVERTIME COSTS: When feasible, if Client requests on the day of the event, extended use of the chocolate fountain **may** be accommodated. Overtime requests may be made in half-hour increments at a cost of **\$50.00** per half-hour not including dippables. Payment is due at the time of request.

CANCELLATION: This agreement can not be cancelled, except in writing, by either the Client or *Charlotte* Chocolate Fountains. If cancellation is initiated by the Client then the deposit will be forfeited. If cancellation by *Charlotte* Chocolate Fountain occurs for any reason under or beyond their control, *Charlotte* Chocolate Fountain's liability will be limited to returning within 7 days all monies prepaid for fountain services subject to this Contract.

PROVISIONS: Charlotte Chocolate Fountain will require access to the desired set up area at least 90 minutes prior to the scheduled start time and 60 minutes after the conclusion of our service, for set up and take down. Client is also responsible for providing a sturdy, level table capable of supporting the Chocolate Fountain and additional food items. (approximately 90# for the small fountain and 150# for the medium and large fountains) Client is also responsible for providing table linens, ample plates and napkins that coordinate with their color scheme. Charlotte Chocolate Fountains requires at least one 120 volt circuit within 8 feet of the desired set up area that adheres to contemporary safety standards and supplies to Charlotte Chocolate Fountains at least 20 amps. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions.

LIABILITY: This Agreement and the contents hereof represent the only warranties, express and implied, between the parties, including any implied warranty of merchantability or fitness for the particular purpose and for any other obligation or liability on the part of *Charlotte* Chocolate Fountains. *Charlotte* Chocolate Fountains shall not be liable for any injury, loss or damage directly or consequently arising out of the use or inability to use the Chocolate Fountain harmless from all claims, actions, proceedings, costs, damages, and liabilities, including attorney fees, arising connected with, or resulting from the use of the Chocolate Fountain.
