Agreements received after 14 days from the contract date are subject to availability. All checks should be made payable to *Charlotte* Chocolate Fountains. There will be a \$30.00 fee charged for all returned checks.

CANCELLATION: This agreement can not be cancelled, except in writing, by either the Client or *Charlotte* Chocolate Fountains. If cancellation is initiated by the Client then the deposit will be forfeited. If cancellation by *Charlotte* Chocolate Fountain occurs for any reason under or beyond their control, *Charlotte* Chocolate Fountain's liability will be limited to returning within 7 days all monies prepaid for fountain services subject to this Contract.

PROVISIONS: Client is also responsible for providing a sturdy, level table capable of supporting the Chocolate Fountain and additional food items. (Approximately 75# for the Mini fountain. Client is also responsible for providing table linens, ample plates and napkins that coordinate with their color scheme. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions.

LIABILITY: This Agreement and the contents hereof represent the only warranties, express and implied, between the parties, including any implied warranty of merchantability or fitness for the particular purpose and for any other obligation or liability on the part of *Charlotte* Chocolate Fountains. *Charlotte* Chocolate Fountains shall not be liable for any injury, loss or damage directly or consequently arising out of the use or inability to use the Chocolate Fountain harmless from all claims, actions, proceedings, costs, damages, and liabilities, including attorney fees, arising connected with, or resulting from the use of the Chocolate Fountain.
